Summary Narrative

- The City of Longmont housing allocation includes \$697,928 dedicated to Housing Rehabilitation\Repair\Replacement program and \$1,000,000 dedicated to the Down Payment Assistance Program. All of the Housing Rehabilitation\Repair\Replacement funding and \$250,000 of Down Payment Assistance program is expected to be spent with the first obligation.
- Boulder County has a housing allocation totaling \$7,906,041 for HAP Programs including Home Access, Temporary Rental Assistance, Rehabilitation, and Clearance and Demo, \$2,802,072 is expected to be spent with the first obligation.
